## SUB-LICENCE FOR SEISMIC DATA

### **TERMS AND CONDITIONS**

Seismic data acquired pursuant to operations conducted subject to the Petroleum Act 1988 and landward area regulations made in exercise of powers conferred thereby are Crown Copyright material. The UK Onshore Geophysical Library ("the Library"), pursuant to worldwide exclusive rights granted by The Controller of Her Majesty's Stationery Office ("the Controller") hereby grants

Example Oil & Gas Ltd

("The Licensee")

a non-exclusive Licence to use the seismic data listed in the Schedule hereto ("the Data") on the following terms and conditions:

#### **1.0 Ownership and Licence**

- 1.1 Title, copyright and all other proprietary rights in the Data remain the property of the Crown.
- 1.2 This Licence may not be transferred or assigned without the prior written consent of the Library.
- 1.3 The Licensee is not permitted to sell or trade this Data or to use the Data to provide a service of any kind to a third party.
- 1.4 If the Licensee permits access to the Data by any person not directly employed by the Licensee, the Licensee shall be liable to the Controller and to the Library for any failure by such person to comply with these terms and conditions as they apply to the Licensee. The Licensee may permit access to the Data to its professional consultants and its affiliated companies, provided that the Licensee obtains from such entities an undertaking of confidentiality in respect thereof. Notwithstanding these liabilities and obligations the Licensee may make use of the Data in confidential submissions to United Kingdom Government bodies.
- 1.5 The Licensee may not copy, distribute or adapt the Data for other than its own internal and exclusive use unless the prior written consent of the Library has been obtained.
- 1.6 If the Licensee is, or at any time hereafter becomes, the operator or a member of a bona fide oil or gas bidding group, exploration group or exploitation group ("a Joint Venture Group") the Licensee may share the use of the Data with another member of such Joint Venture Group ("a Group Member") providing:-

## SUB-LICENCE FOR SEISMIC DATA

- (a) the Library in its absolute discretion is satisfied that the Licensee and Group Member are members of a Joint Venture Group; and
- (b) the Group Member agrees to be bound by these terms and conditions to the same extent as the Licensee.

1.7 If the Licensee is an academic institution in a Member State of the European Communities or a member of staff or a student of such academic institution and as such has been granted this Licence without payment of a Licence fee, the Data may not be used for commercial gain or to create a competitive product or compilation. In the event of any contravention of this condition 1.7 in addition to any other rights resulting from such contravention a full Licence fee in accordance with the current published price list shall be payable by the Licensee to the Library forthwith and without demand.

### **2.0 Limitation of Liability**

- 2.1 Neither the Crown nor the Library will be liable in contract or in tort for any loss, damage, expense or injury of any nature, whether or not such matter amounts to a fundamental breach of a fundamental contractual term, suffered by the Licensee or any other party as a result of the use of or reliance on any of the Data or of any errors or omissions in the Data or of any faults in the media on which the Data are recorded.
- 2.2 The Library disclaims all warranties express or implied, excluding but not limited to warranties of merchantability, quality or fitness for any purpose and non-infringement of third party rights in respect of the Data.
- 2.3 If any of the above provisions or portions thereof are invalid or unlawful under any applicable law, they are to that extent only deemed omitted.

### **3.0 Termination**

- 3.1 Without prejudice to any other rights or remedies of the Library, the Library may terminate this Licence forthwith by written notice to the Licensee if:
  - (a) the Licensee commits a breach of this Licence and fails to remedy such breach within 30 days of a written notice from the Library specifying the breach, or
  - (b) the Licensee goes into liquidation (except for amalgamation or reconstruction).

For the purpose of this sub-clause notice shall be deemed to have been served on the Licensee 48 hours after posting by first class post to the last address of the Licensee known to the Library.
